The Juvenile Court of Houston County respectfully requests that the Court Rooms' Camera and microphones be upgraded to meet the legal requirements of having a good record of a case. Currently, the statements made in the galley of the courtroom, where the Department of Family and Children Services (DFCS), CASA (Court Appointed Special Advocate Volunteers) and families sit, are not captured or recorded properly as part of the hearing record. *By statute we are required to maintain a complete and accurate record of everything that transpires during a hearing*. The microphones will allow multiple family members involved in the conversation with the Judge to be heard and recorded properly. A good record means that if the case were appealed, the parties involved are heard on the recording and said recording will serve as the minutes of the hearing. Also, the recording would be heard properly for a transcriptionist, if needed.

Additionally, since COVID, we continue to have Zoom hearings on occasion. The quality of the camera for the Court to view the witness, and/or party, is important. In addition, the party on the Zoom hearing can see all the witnesses, the Judge, and attorneys who are involved in the case.
