## **MEETING MINUTES** Tuesday, December 1, 2020

The December 1, 2020 meeting of the Houston County Board of Elections was called to order at 5:34 p.m. by Chairman Katherine Shelton.

Chairman Shelton called for the approval of the minutes of the November 3, 2020 and November 6, 2020 meetings. A motion was made by John Applegate and seconded by Henry Childs to approve the November 3, 2020 and the November 6, 2020 meeting minutes. The motion carried.

## REGISTRATION/ELECTION SUPERVISOR REPORT:

Currently, we have 1,431 Drivers' Services Voter Registrations, 181 Mailed-In Registrations and 776 On-line Registrations to process. The voter registration deadline for the January 5, 2021 General/Special Runoff Election is December 7, 2020.

There are approximately 9,800 voters who are on the Disabled/Elderly Roll-over List. These voters will automatically receive an absentee ballot for the January 5, 2021 General/Special Runoff Election. These ballots will be mailed by the Secretary of State to elderly/disabled voters who requested an absentee ballot for earlier elections in 2020.

To date, Houston County has mailed 5,285 regular ballots and 486 electronic ballots. Houston County is responsible for mailing all ballots through the end of the General/Special Runoff Election.

Because of the holiday schedule all three early voting locations will open the same time.
