Old Business:

Currently, voters that registered with missing residential street addresses are entered into the election system as challenged voters. The potential voter is sent a letter with a new registration application. If there is a phone number or an email address on the application, the office calls or emails the potential voter. The standard time to hold information before rejecting an application is forty-five days. The Board was asked would you like to adopt another option or leave standard office procedure as is.

Chairman Henry Childs called for a motion from the Board. A motion was made by Andrew Bennett and seconded by Sherman Falana to continue to use current standard office procedure of potential voters will be given forty-five days to rectify missing residential street addresses. The motion carried.

Chairman Henry Childs addressed the public concerns of Candidate Charlie Bibb allegedly inside polling locations during the November 7, 2023 General Election. The Board formed an investigative team (Andrew Bennett, Katherine Shelton, Sherman Falana) to report findings. Chairman Henry Childs yield the floor to Andrew Bennett to read public statement (statement attached). The report and all findings will be turned over to the appropriate state agency, Mr. Tom Hall (Houston County, County Attorney), and Ms. Julia Mize, Esq. (Warner Robins City Attorney). The Board referred follow-up questions from the public to the County Attorney, City Attorney, and State Agency.
